Subject: notice about the Italian law dated 31.12.1996 n° 675 "defence of the persons and other subjects regarding the treatment of the personal data", named "privacy" law.

We inform you, as specified in article 10 of the law in subject, that your personal and family data, that could come in our possession and that we collect in this and other occasions, are stored on informatics supports. They are used for the purpose of sending information and materials related to the association activity, or similar initiatives promoted by other associations, institutions and subjects that collaborate with Eamas. The treatment of such personal data follows the instructions given at article 1, comma 2, letter b) of the law, thereof, we may proceed with: storage, organization, conservation, elaboration, modification, selection, cancellation and destruction of such personal data. We take the occasion to inform you that your authorization to collect and store your personal data is optional but, without it, we will not be in position to proceed forward with our collaboration. According to article 13, you may demand at any moment, the confirmation of the existence of such data, their communication, the update, the verification, the cancellation or the transformation in anonymous form, of such data addressing your written request to Eamas association.
